

Notice of Liability

Parental & Student Rights

This Notice of Liability, Parental and Student Rights, informs those involved with issuing and attempting to enforce any and all “medical mandates” of the following, as it pertains to both public and private education, K-12, and all college admissions and institutions of higher learning;

1. Under the Fourth Amendment to the U.S. Constitution, you are hereby notified that every legal Citizen of the United States has an inalienable Right to be “*secure in their person;*”
2. That the legal parents of the student in question, hold sole legal Parental Rights and sole legal guardianship as it pertains to the student, and that we hereby exercise all Parental Rights to determine what is in the best health interest of the student, and that ALL Rights are held by either the Parent for students under age 18, or still under the legal guardianship of the parents, or the student, if they are of legal age and solely responsible for themselves;
3. That all public and private education institutions are funded by and therefore obligated to, the will of the parents and taxpayers who fund these institutions;
4. That the will of any majority does not eliminate, limit, or otherwise supersede the individual Rights of any minority group or individual;
5. That people who are not trained, certified, and licensed to practice medicine, are hereby forbidden from issuing or enforcing any “medical mandates” or otherwise practicing medicine without proper training and licensing, and without “written informed consent” of the student’s legal guardian;
6. That the parents of said student, reserves all Rights to make all decisions pertaining to the health and well-being of student, including but not limited to all masking, vaccinating, social distancing, quarantine, isolation, as deemed appropriate by the parent[s] and/or sole legal guardians of said student;
7. That the education institution is strictly prohibited from any and all attempts to enforce unlawful and unconstitutional “medical mandates” or in any way, isolate, coerce, intimidate, segregate, punish or otherwise target the student on the basis of “medical decisions” that are the sole responsibility of the legal guardian, under full Parental and Student Rights.
8. That in the event the institution or its employees violate any of the above, they hereby acknowledge and accept all legal liability for any and all damages that may arise out of the institutions or individual efforts to deprive student and/or parents of their inalienable constitutionally protected Natural Rights under the Fourth Amendment to the U.S. Constitution and all Federal, State and Local protections of Civil Rights and Civil Liberties;
9. That NO ONE HAS THE RIGHT TO FORCE OR COERCE INJECT ANYONE WITH ANYTHING, MASK, ISOLATE, SEGREGATE, INTIMIDATE, QUARANTINE, OR PUNISH ANYONE AGAINST THEIR WILL, FOR ANY REASON WHATSOEVER.

The undersigned, both on behalf of employer and personally, hereby acknowledges and accepts all legal liability for their actions, in the event that the undersigned chooses to take any action which directly or indirectly violates Parental and/or Student Rights as described herein. Undersigned hereby understands and accepts full responsibility for any cause of action which may arise from any and all “deprivation of Rights” resulting from unlawful and unconstitutional violations under “medical mandates,” issued and/or enforced by undersigned.
